The term of the chairperson and members of SGRC shall be for a period of two years from the date of issue of this Notification. Students' Grievance Redressal Committee (SGRC), of Vishwavidyalaya shall exercise its powers and functions as per the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.

Any complaint by aggrieved student relating to the Vishwavidyalaya shall be addressed to the Chairperson, SGRC. The SGRC shall send its report with recommendations, if any, to the competent authority of the Vishwavidyalaya and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint. Any student, if, aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.

B. Ombudsperson

The Hon'ble Vice Chancellor, Birangana Sati Sadhani Rajyik Vishwavidyalaya is pleased to appoint the following as **Ombudsperson** as per the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023:

Prof. (Retd.) Gopal Hazarika, Former Professor, Dept of Mathematics, DU.


The term of the Ombudsperson shall be for a period of three years or until he/she attains the age of 70, whichever is earlier, from the date of issue of this Notification.

The Ombudsperson shall hear appeals from an aggrieved student, only after the student has availed all other remedies provided under these regulations. The Ombudsperson shall make all efforts to

resolve the grievances within a period of 30 days of receiving the appeal from the aggrieved student(s). The Ombudsperson may avail assistance of any person, as amicus curiae, for hearing complaints of alleged discrimination.


